I am Janice Levering King, daughter of re:MIND's founder Gary Levering. I struggled to acknowledge my Dad's brave acceptance of his bipolar diagnoses and his willingness to overcome potential shame around the stigma of mental illness.

He opened himself up to supporting other families and individuals as they addressed their shame in order to seek help.

I could not accept my dad's diagnoses myself in any real way. Turns out my denial then inhibited me from learning about the disease of bipolar in order to see the signs of bipolar in my spouse. Today, I stand in awe of my dad and every individual and family who joins and supports re:MIND's efforts to not only support those who suffer from mental illness but to also provide tangible

and much- needed resources toward proper diagnoses and treatment and vital support groups.

re:MIND hosted its Eleventh Annual Circles of Hope Luncheon on September 20, 2022.

The Circles of Hope Luncheon was a special event as chairs Jennifer and Walter O'Donnell hosted the first in person luncheon since 2019. The event raised nearly \$285,000 in support of re:MIND's life-saving mission: to provide free and confidential mental health support groups for individuals living with, and family and friends affected by, depression and bipolar disorders.

This year, re:MIND was proud to honor Dr. Jan Redford with the Gary Levering Mental Health Impact Award. Honoring Dr. Jan Redford was especially appropriate as it brought historical focus back to the beginning vision of Gary Levering. She and an enthusiastic group of volunteer leaders embarked on a remarkable journey to bring support and hope to people experiencing depression or bipolar disorder. Jan had been working for many years as a Psychologist at the University of Houston (UH) where every day she encountered students suffering from these debilitating illnesses. She found over the years that after her clients concluded treatment, they still needed mental health support at a cost they could afford. With the development of a Board of Directors and the forming of working committees, Gary's vision of support groups throughout Houston became a reality. Jan served as Chairman of the Board in 2010 and then served as Interim Director during 2011.
